ROADCHECK 2020 INTERNATIONAL ROADCHECK: DRIVER REQUIREMENTS

The emphasis for 2020 International Roadcheck will be on roadside inspection driver requirements. The Commercial Vehicle Safety Alliance (CVSA) chose to focus on driver requirements this year to highlight the importance of this vital category of the roadside inspection process.

Violations of the following may render the commercial motor vehicle driver unqualified to drive and will preclude further operation of the vehicle by its driver for a specified amount of time or for some violations, until the required condition is met:

- Driver's age
- Commercial driver's license or operator's/chauffeur's license or permit
- Driver medical/physical requirements
- Sickness or fatigue
- Intoxicating beverages and drugs and other substances
- Driver's record of duty status U.S., Canada or Mexico



These are the top 10 driver-related violations found during driver roadside inspections:

- **1.** Failure to use a seat belt while operating a commercial motor vehicle
- 2. Record of duty status violation (general/form and manner)
- **3.** Operating a property-carrying vehicle without a valid medical certificate
- 4. Operating a commercial motor vehicle without a CDL
- 5. False report of record of duty status
- ELD No record of duty status (ELD is required)
- 7. No medical certificate in driver's possession
- 8. Driver's record of duty status not current
- Driver failed to maintain supply of blank records of duty status graph grids
- Driver failed to maintain ELD instruction sheet

- Driver's license or commercial driver's license (class, endorsements and restrictions)
- Medical Examiner's Certificate and Skill Performance Evaluation Certificate, if applicable
- Record of duty status, if applicable and any supporting documents
- Illegal presence of alcohol, drugs, weapons or other contraband
- Illness, fatigue or other signs of impairment
- Seat belt usage and condition
- Evidence of periodic inspection
- Driver's daily vehicle inspection report, if applicable
- Carrier identification and status (USDOT/NSC Number, or jurisdictional equivalent)
- 🕑 Operating authority, if applicable
- Vehicle registration(s)
- Proof of insurance
- Fuel tax permits, if applicable
- Shipping papers/bills of lading
- 👩 Special permits, if applicable
- Certificate for Mexico-domiciled motor carriers, if applicable
